

ORDINANCE NO. 46-2012

**AN ORDINANCE OF THE MAYOR AND COMMITTEE OF TOWNSHIP OF HARRISON,
COUNTY OF GLOUCESTER, STATE OF NEW JERSEY AMENDING CHAPTER 214
ENTITLED "VEHICLES AND TRAFFIC" OF THE CODE OF THE TOWNSHIP OF HARRISON**

WHEREAS, the Mayor and Committee, Township of Harrison, have determined that certain amendments and additions to Chapter 214 entitled "Vehicles and Traffic" are necessary; and

WHEREAS, via Resolution No. 46-2007, the Harrison Township Planning Board granted final major subdivision approval for the subdivision commonly known as "Clems Run Estates" affecting Block 17, Lot 10; and

WHEREAS, as a condition of approval, Paragraph 26 of the Harrison Township Planning Board's Resolution prohibits parking on either side of the internal roadway known as Gehring Court; and

WHEREAS, in all other respects Chapter 214 entitled "Vehicles and Traffic" shall remain in full force and effect;

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Committee of the Township of Harrison, in the County of Gloucester and State of New Jersey, and it is hereby enacted and ordained by the authority of same as follows:

Section 1.

§214-14 entitled "Parking prohibited at all times on certain streets" shall be amended to add the following text:

Name of Street	Side	Location
<u>Gehring Court</u>	<u>Both</u>	<u>Entire length</u>

Section 2.

Severability.

Should any section, clause, sentence, phrase or provision of this Ordinance be declared unconstitutional or invalid by a Court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.

Section 3.

Repealer.

All prior Ordinances or parts of Ordinances inconsistent with this Ordinance be and the same are hereby repealed to the extent of such inconsistencies.

Section 4.

In all other respects, Chapter 214 entitled "Vehicles and Traffic" shall remain in full force and effect.

Section 5.

When effective.

This Ordinance shall take effect immediately upon final passage and publication in accordance with law.
