

**ORDINANCE NO. 27-2013**

**AN ORDINANCE OF THE TOWNSHIP OF HARRISON, COUNTY OF GLOUCESTER,  
STATE OF NEW JERSEY AUTHORIZING THE ACQUISITION OF REAL PROPERTY  
IDENTIFIED AS BLOCK 60, LOT 1.19; BLOCK 34, LOT 46; AND BLOCK 61, LOT 23  
ON THE MUNICIPAL TAX MAP OF HARRISON TOWNSHIP**

**WHEREAS**, the County of Gloucester is the owner of Block 60, Lot 1.19; Block 34, Lot 46; and Block 61, Lot 23 located in the Township of Harrison; and

**WHEREAS**, Block 60, Lot 1.19 consists of approximately .57 acres; Block 34, Lot 46 consists of approximately 2.47 acres; and Block 61, Lot 23 consists of approximately .19 acres; and

**WHEREAS**, the County of Gloucester acquired the properties in conjunction with the Route 322 By-Pass construction project; and

**WHEREAS**, the County of Gloucester has indicated a desire to donate and transfer the properties to the Township of Harrison for the sum of \$1.00; and

**WHEREAS**, it would be in the best interests of the residents of the Township of Harrison to accept the donation of Block 60, Lot 1.19; Block 34, Lot 46; and Block 61, Lot 23 from the County of Gloucester.

**NOW, THEREFORE, BE IT ORDAINED**, by the Mayor and Committee of the Township of Harrison, in the County of Gloucester and State of New Jersey, and it is hereby enacted and ordained by the authority of same as follows:

1. The acquisition by donation from the County of Gloucester of the real property identified on the Township of Harrison Tax Map as Block 60, Lot 1.19; Block 34, Lot 46; and Block 61, Lot 23 is hereby authorized.
2. The Mayor and the Clerk are further authorized to execute an Agreement of Sale and any and all Amendments, Addendums or any other documents to effectuate the purposes hereof.

**When effective.**

This Ordinance shall take effect immediately upon final passage and publication in accordance with law.
