

ORDINANCE NO. 17-2016

AN ORDINANCE OF THE MAYOR AND COMMITTEE OF TOWNSHIP OF HARRISON, COUNTY OF GLOUCESTER, STATE OF NEW JERSEY AMENDING THE 2016 SALARY ORDINANCE (ORDINANCE NO. 01-2016) TO ADD A POSITION OF "DETECTIVE" TO THE HARRISON TOWNSHIP POLICE DEPARTMENT, AND THE SALARY RANGE RELATED THERETO

WHEREAS, via Ordinance No. 01-2016, the Mayor and Committee, Township of Harrison, adopted the 2016 Salary Ordinance; and

WHEREAS, certain amendments to the 2016 Salary Ordinance are necessary; and

WHEREAS, in all other respects 2016 Salary Ordinance shall remain in full force and effect.

NOW, THEREFORE BE IT ORDAINED by the Mayor and Committee of the Township of Harrison, Gloucester County and State of New Jersey, that the 2016 Salary Ordinance of the Township of Harrison is hereby amended as follows:

Section 1.

The following new position and salary range shall be added to the 2016 Salary Ordinance:

Section 2.

Repealer.

All prior Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistencies.

Section 3.

Severability.

Should any section, clause, sentence, phrase or provision of this Ordinance be declared unconstitutional or invalid by a Court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.

Section 4.

When effective.

This Ordinance shall take effect immediately upon final passage and publication in accordance with law.
