**ORDINANCE AMENDING BOND ORDINANCE 9-2015 OF  
THE TOWNSHIP OF HARRISON, COUNTY OF  
GLOUCESTER, NEW JERSEY**

**BACKGROUND**

**WHEREAS**, the Township of Harrison, County of Gloucester, New Jersey ("Township") has heretofore duly and finally adopted Bond Ordinance 9-2015 authorizing the acquisition of various pieces of equipment and the completion of various capital improvements in and for the Township ("Bond Ordinance"); and

**WHEREAS**, the Township is desirous of amending the Bond Ordinance to broaden the purposes authorized under Section 7(D).

**BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF HARRISON, COUNTY OF GLOUCESTER, NEW JERSEY (NOT LESS THAN TWO-THIRDS OF ALL THE MEMBERS THEREOF AFFIRMATIVELY CONCURRING), PURSUANT TO THE PROVISIONS OF THE LOCAL BOND LAW, CHAPTER 169 OF THE LAWS OF 1960 OF THE STATE OF NEW JERSEY, AS AMENDED AND SUPPLEMENTED ("LOCAL BOND LAW"), AS FOLLOWS:**

**Section 1.** Section 7(D) of the Bond Ordinance is hereby amended to provide as follows:

Acquisition of Various Equipment for the Public Works Department including, but not limited to, a Street Sweeper, Contour Mower and Compact Track Loader, together with the acquisition of all materials and equipment and completion of all work necessary therefor or related thereto	310,000	15,500	294,500	10 years

"

**Section 2.** The capital budget is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency therewith and the regulations promulgated by the Local Finance Board showing full detail the amended capital budget and capital improvement program as approved by the Director of the Division of Local Government Services, New Jersey Department of Community Affairs, are on file with the Clerk and available for public inspection.

**Section 3.** All other parts of the Bond Ordinance not amended hereby shall remain in full force and effect.

**Section 4.** In accordance with the Local Bond Law, this ordinance shall take effect twenty (20) days after the first publication thereof after final passage
