

RESOLUTION NO. 177-2013

**RESOLUTION OF THE MAYOR AND COMMITTEE OF THE TOWNSHIP OF HARRISON
GRANTING SERGEANT RICHARD MALINOSKI PERMISSION
TO PURCHASE HIS SERVICE FIREARM (SIG SAUER P229, .40 CAL. SEMI-AUTOMATIC
PISTOL SERIAL NUMBER AG19265) UPON HIS RETIREMENT FROM THE HARRISON
TOWNSHIP POLICE DEPARTMENT ON NOVEMBER 30, 2013**

WHEREAS, the Township has in the past, granted certain retiring police officers their service firearms upon their retirement from the Harrison Township Police Department; and

WHEREAS, Richard Malinoski has served with the Harrison Township Police Department for 27 years and will retire in good standing from the Harrison Township Police Department on November 30, 2013; and

WHEREAS, Harrison Township requires any officer requesting award of his/her service firearm as part of his/her retirement to qualify for a firearm permit to own and possess such firearm after retirement; and

WHEREAS, Richard Malinoski has qualified for a firearm permit pursuant to state statute upon a review by Chief Thomas Mills, which letter is attached hereto and incorporated herein by reference; and

WHEREAS, state statute also permits retired police officers to carry a firearm pursuant to N.J.S.A. 2C:39-6(l), where a full-time member of a municipal police department retires in good standing and semi-annually qualifies in the use of the handgun, he is permitted to carry in accordance with the requirements and procedures established by the Attorney General pursuant to N.J.S.A. 2C:39-6(j), and if he pays the actual costs associated with those semi-annual qualifications, and is less than 75 years of age, and was regularly employed as a full-time member of a municipal police department in this State; he is also permitted to carry a handgun in the same manner as law enforcement officers under paragraph (7) of subsection a. of N.J.S.A. 2C:39-6.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Committee of the Township of Harrison, County of Gloucester and State of New Jersey, that upon retirement, Sergeant Richard Malinoski is hereby granted his service firearm (Sig Sauer Model P229, .40 CAL. semi-automatic pistol Serial Number AG19265) and one additional magazine (2 total) for the sum of \$200.00.
