

RESOLUTION NO. 189-2013

RESOLUTION BY THE TOWNSHIP COMMITTEE, IN THE TOWNSHIP OF HARRISON, COUNTY OF GLOUCESTER AND STATE OF NEW JERSEY AUTHORIZING THE PURCHASE OF FOUR (4) DOOSAN PORTABLE LIGHT TOWER, LS-60 FROM PENN JERSEY MACHINERY

WHEREAS, the Township of Harrison wishes to purchase four (4) **DOOSAN PORTABLE LIGHT TOWER, LS-60** from an authorized vendor under Penn Jersey Machinery, LLC; and

WHEREAS, the Township of Harrison is permitted to join national cooperative purchasing agreements under the authority of N.J.S.A. 52:34-6.2(b)(3); and

WHEREAS, Penn Jersey Machinery, LLC has been awarded HGAC Contract No. CM02-13 for **DOOSAN PORTABLE LIGHT TOWER, LS-60**; and

WHEREAS, the Township Administrator recommends the utilization of this contract on the grounds that it represents the best price available; and

WHEREAS, the actual cost for the purchase of four (4) **DOOSAN PORTABLE LIGHT TOWER, LS-60 WITH BALL HITCH** is expected not to exceed **\$35,200.00**; and

NOW, THEREFORE, BE IT RESOLVED By the Township Committee of the Township of Harrison, County of Gloucester and State of New Jersey, as follows:

1. Penn Jersey Machinery, LLC, 9601 Boggy Creek Road, Orlando, Florida 32824-8728 shall be awarded a contract pending the completion of the legal advertising requirements. Said contract shall be in an amount not to exceed \$35,200.00 to supply four (4) **DOOSAN PORTABLE LIGHT TOWER, LS-60 WITH BALL HITCH** for the Township.

2. A Certification of Funds has been received for the said contract assuring that there is a sufficient appropriation to award this contract and the availability of a sufficient appropriation to fund the purchase authorized in this resolution is an express and mandatory condition of the award of this contract.

3. The Township Administrator hereby is authorized to sign the contract documents necessary to effectuate the award of this contract as detailed herein.
