

**RESOLUTION NO. 190-2013**

**RESOLUTION OF THE MAYOR AND COMMITTEE OF THE TOWNSHIP OF HARRISON  
AUTHORIZING AND REQUESTING THE REASSIGNMENT OF LOT NUMBERS FOR BLOCK  
38, LOTS 6 AND 6.02**

**WHEREAS**, the Township of Harrison acquired Block 38, Lot 6 by Deed dated October 17, 1997; and

**WHEREAS**, in or about December 2000, the parcel was subdivided whereby the Township conveyed 14.16 acres to the Harrison Township Board of Education; and

**WHEREAS**, thereafter, the Harrison Township Board of Education conveyed to the Township of Harrison Block 38, Lot 7.02 consisting of 22.72 acres; and

**WHEREAS**, by Deed dated January 8, 2001 entitled "Consolidation Deed", existing Block 38, Lot 6 and Block 38, Lot 7.02 were consolidated into one lot identified as Block 38, Lot 6 consisting of approximately 68 acres; and

**WHEREAS, the entirety of** Block 38, Lot 6 was inadvertently included on the Green Acres Recreation and Open Space Inventory list ("ROSI") in or about 2002; and

**WHEREAS**, in or about 2010, the Township's Public Works Facility was constructed on the southerly portion of Block 38, Lot 6; and

**WHEREAS**, on June 2, 2011, the Harrison Township Planning Board, via Resolution 27-2011, granted a minor subdivision approval for the purpose of subdividing Block 38, Lot 6 into three (3) distinct lots to delineate the Green Acres tract (43± acres); the Public Works Facility (19± acres); and a vacant parcel (6± acres); and

**WHEREAS**, although intended to be identified as Block 38, Lot 6, the Green Acres tract was inadvertently identified as Lot 6.02, and the Public Works Facility tract was intended to be identified as Lot 6.02, but was inadvertently identified as Lot 6; and

**WHEREAS**, the Harrison Township Committee authorizes and requests the Gloucester County Tax Assessor to reassign the lot numbers within Block 38 as follows:

Existing Block 38, Lot 6.02 to become Block 38, Lot 6  
Existing Block 38, Lot 6 to become Block 38, Lot 6.02

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Committee of the Township of Harrison, County of Gloucester and State of New Jersey that the Gloucester County Tax Assessor is hereby authorized and requested to reassign the lot numbers within Block 38 as follows:

Existing Block 38, Lot 6.02 to become Block 38, Lot 6  
Existing Block 38, Lot 6 to become Block 38, Lot 6.02
