

**RESOLUTION NO. 204-2013**

**RESOLUTION OF THE MAYOR AND COMMITTEE OF THE TOWNSHIP OF HARRISON  
AUTHORIZING THE ACCEPTANCE OF CONTRIBUTION IN LIEU OF COMPENSATORY  
TREE PLANTING FROM COLLISION CARE, INC.**

**WHEREAS**, Collision Care, Inc. was granted Final Major Site Plan approval by the Harrison Township Board of Adjustment via Resolution No. 10-2011 on March 30, 2011 regarding 409 Swedesboro Road and identified as Block 46, Lot 3.01 on the Municipal Tax Map of the Township of Harrison; and

**WHEREAS**, via Resolution No. 30-2012, Collision Care, Inc. was granted an extension of time in which to perfect the Major Site Plan approval granted via Resolution No. 10-2011; and

**WHEREAS**, in lieu of compensatory tree planting, the Applicant agreed to provide the Township with a payment in the sum of \$8,000.00 as a direct contribution, or by conducting off-site landscaping for the same amount, or by providing an in-kind contribution by way of dedication of man hours for the painting of guardrails for the same amount; and

**WHEREAS**, the Applicant has contributed \$4,100.00 towards "in-kind" labor hours for painting the guardrails along Main Street (Route 45) bridge; and

**WHEREAS**, \$3,900.00 remains to satisfy Condition #13 of Resolution 30-2012; and

**WHEREAS**, the Mayor and Committee of the Township of Harrison have determined that the Applicant shall pay the remaining balance in the sum of \$3,900.00 as a direct contribution towards the Compensatory Planting Fund.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Committee of the Township of Harrison, County of Gloucester and State of New Jersey that the Township of Harrison will accept the remaining balance in the amount of \$3,900.00 as a direct contribution towards Compensatory Planting Fund to satisfy Condition #13 of Resolution 30-2012.

**ADOPTED** at a regular meeting of the Mayor and Township Committee of the Township of Harrison, County of Gloucester, State of New Jersey held on December 2, 2013.
