

RESOLUTION NO. 208-2013

**RESOLUTION OF THE TOWNSHIP OF HARRISON AWARDING CONTRACT TO
MCGOVERN ENVIRONMENTAL, LLC FOR HAULING AND DISPOSAL OF RAW
WASTEWATER FOR THE WASTEWATER TREATMENT FACILITY**

WHEREAS, the Mayor and Committee of the Township of Harrison advertised and solicited bids pursuant to N.J.S.A. 40A:11-4 for the hauling and disposal of raw wastewater for the wastewater treatment facility; and

WHEREAS, bids were received and opened on December 4, 2013 at 2:30 p.m.; and

WHEREAS, three (3) bids were received by the Township's Administrator; and

WHEREAS, McGovern Environmental submitted the lowest bid in the sum of \$.0675; and

WHEREAS, the bid submitted by McGovern Environmental, LLC is the lowest monetary responsive bid; and

WHEREAS, the Township's Administrator and Solicitor have determined that the bid is in conformance with the Bid Specifications and Local Public Contracts Law; and recommend the award of the Contract to McGovern Environmental, LLC; and

WHEREAS, the Township's Chief Financial Officer has certified that sufficient funds are available to award the Contract.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Committee of the Township of Harrison that the Contract for the hauling and disposal of raw wastewater for the wastewater treatment facility be and the same is hereby awarded to McGovern Environmental, LLC on its bid of \$.0675 subject to the conditions set forth below.

BE IT FURTHER RESOLVED that the Mayor and Clerk of the Township of Harrison are hereby authorized and directed to execute the Contract for same.

BE IT FURTHER RESOLVED that the certified checks or bid bonds of the successful bidder and next lowest bidder are to be returned upon the receipt of fully executed Contract and other required documents by the lowest bidder, McGovern Environmental, LLC.
