

RESOLUTION NO. 195-2014

**RESOLUTION OF THE MAYOR AND COMMITTEE OF THE TOWNSHIP OF HARRISON
AUTHORIZING THE PURCHASE OF A FOUR CAMERA MOBILE AUTO LICENSE
PLATE READER SYSTEM FROM GENERAL SALES ADMINISTRATION,
T/A MAJOR POLICE SUPPLY, AN APPROVED STATE CONTRACT VENDOR,
FOR THE SUM OF \$18,457.18**

WHEREAS, the Police Department has requested approval for the purchase of a Four Camera Mobile Auto License Plate Reader System; and

WHEREAS, the Township Committee has considered the Police Department's need for this Auto License Plate Reader; and

WHEREAS, General Sales Administration, t/a Major Police Supply, was awarded State Contract #80311 and GSA Schedule #GS-35F-0574X for the sale of such equipment; and

WHEREAS, the Township of Harrison, pursuant to N.J.S.A. 40A:11-12a and N.J.A.C. 5:34-7.29(c) may by resolution and without advertising for bids, purchase any goods or services under the State of New Jersey Cooperative Purchasing Program for any State Contracts entered into on behalf of the State by the Division of Purchase and Property in the Division of the Treasury; and

WHEREAS, the Chief Financial Officer has certified that sufficient funding exists for this purchase.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Committee of the Township of Harrison, County of Gloucester and State of New Jersey that the purchase of a Four Camera Mobile Auto License Plate Reader System for the sum of \$18,457.18 from General Sales Administration, t/a Major Police Supply, 47 N. Dell Avenue, Kenvil, New Jersey 07847, an approved State Contract Vendor #80311, is hereby approved.

BE IT FURTHER RESOLVED that a copy of this Resolution shall be forwarded to the Township Administrator, Chief of Police, Chief Financial Officer, Purchasing Department and any other interested parties.
