

RESOLUTION NO. 196-2014

**RESOLUTION BY THE TOWNSHIP COMMITTEE, IN THE TOWNSHIP OF HARRISON,
COUNTY OF GLOUCESTER AND STATE OF NEW JERSEY AUTHORIZING THE
PURCHASE OF ONE (1) 2014 KENWORTH T470 TANDEM AXLE TRUCK CHASSIS WITH
PUBLISHED OPTIONS THROUGH THE HOUSTON GALVESTON AREA COUNCIL, A
NATIONAL MUNICIPAL CONTRACTING AGENCY**

WHEREAS, the Township of Harrison wishes to purchase one (1) **2014 KENWORTH T470 TANDEM AXLE TRUCK CHASSIS WITH PUBLISHED OPTIONS** from an authorized vendor under the Houston Galveston Area Council, a national municipal contracting agency; and

WHEREAS, the Township of Harrison is permitted to join national cooperative purchasing agreements under the authority of N.J.S.A. 52:34-6.2(b)(3); and

WHEREAS, the Houston Galveston Area Council has been awarded Contract No. HT06-14 for one (1) **2014 KENWORTH T470 TANDEM AXLE TRUCK CHASSIS WITH PUBLISHED OPTIONS**; and

WHEREAS, the Deputy Township Administrator recommends the utilization of this contract on the grounds that it represents the best price available; and

WHEREAS, the cost for the purchase of one (1) **2014 KENWORTH T470 TANDEM AXLE TRUCK CHASSIS WITH PUBLISHED OPTIONS** is \$130,424.00; and

WHEREAS, the contract award will be withdrawn if any objections or competitive quotes are delivered to you on or before the expiration of the ten day comment period.

NOW, THEREFORE, BE IT RESOLVED By the Township Committee of the Township of Harrison, County of Gloucester and State of New Jersey, as follows:

1. **FRENCH ELLISON TRUCK CENTER, PO BOX 200187, SAN ANTONIA TEXAS 78220** shall be awarded a contract pending the completion of the legal advertising requirements. Said contract shall be in an amount not to exceed **\$130,424.00** to supply one (1) **2014 KENWORTH T470 TANDEM AXLE TRUCK CHASSIS WITH PUBLISHED OPTIONS** for the Township.

2. A Certification of Funds has been received for the said contract assuring that there is a sufficient appropriation to award this contract and the availability of a sufficient appropriation to fund the purchase authorized in this resolution is an express and mandatory condition of the award of this contract.

3. The Deputy Township Administrator hereby is authorized to sign the contract documents necessary to effectuate the award of this contract as detailed herein.
