

**RESOLUTION NO. 197-2014**

**RESOLUTION BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF HARRISON, IN THE COUNTY OF GLOUCESTER, STATE OF NEW JERSEY AUTHORIZING AND APPROVING CHANGE ORDER NO. 5 TO THE CONTRACT WITH CLYDE LATTIMER & SONS CONSTRUCTION COMPANY FOR THE BREAKNECK ROAD PEDESTRIAN TUNNEL PROJECT**

**WHEREAS**, the Township Committee of the Township of Harrison is satisfied that a need for the following change order exists and that it is not reasonably possible to execute a new contract for the additional work; and

**WHEREAS**, the Township Committee adopted Resolution No. 145-2014 during their meeting of August 8, 2014 approving change orders No. 1 and No. 2 in the aggregate amount of \$20,288.42; and

**WHEREAS**, the Township Committee adopted Resolution No. 174-2014 during their September 3, 2014 meeting approving change order No. 3 in the amount of -\$2432.53; and

**WHEREAS**, the Township Committee adopted Resolution No. 181-2014 during their September 15, 2014 meeting approving change order No. 4 in the amount of \$3,712.25; and

**WHEREAS**, the project engineer has submitted a recommendation for change order No. 5 which provides an overall increase of \$12,769.30

**NOW THEREFORE, BE IT RESOLVED** this 18th day of September, 2014 that the following change orders be and the same is hereby approved and authorized:
