

RESOLUTION NO. 078-2014

RESOLUTION BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF HARRISON, IN THE COUNTY OF GLOUCESTER, STATE OF NEW JERSEY AWARDING A CONTRACT TO LANDBERG CONSTRUCTION, LLC, PO BOX 280, MAYS LANDING NEW JERSEY FOR THE HEILIG ROAD PHASE I ROADWAY IMPROVEMENTS

WHEREAS, the Township Committee of the Township of Harrison has determined that it is in the public interest to award a contract to Landberg Construction, LLC, for the Heilig Road Phase I Roadway Improvements; and
