**RESOLUTION OF THE MAYOR AND COMMITTEE OF THE TOWNSHIP OF HARRISON
AUTHORIZING AN APPLICATION BE MADE FOR FUNDING THE MANTUA HARRISON
MUNICIPAL ALLIANCE FOR THE TERM YEAR 2014 IN THE TOTAL BUDGET AMOUNT OF
\$35,953.00**

WHEREAS, The Township Committee of the Township of Harrison, in the County of Gloucester and State of New Jersey recognizes that the abuse of alcohol and drugs is a serious problem in our society amongst persons of all ages; and

WHEREAS, the Township Committee further recognizes that it is incumbent upon not only public officials, but upon the entire community to take action to prevent such abuses in our community; and

WHEREAS, the Township Committee / Mantua Township, on behalf of the Mantua Harrison Municipal Alliance, has applied for funding to the New Jersey Governor's Council on Alcoholism and Drug Abuse through the County of Gloucester.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Harrison, on this 5th day of March, 2014, hereby recognizes the following:

- A. The Township Committee does hereby authorize the submission of an application for the Mantua Harrison Municipal Alliance grant for the calendar year 2014 in the total budgeted amount of \$37,953.00 and includes the following:

Alliance DEDR Total = \$18,977.00
Cash Match = \$4744.00
In-Kind Match = \$14,232.00
Total Alliance Budget = \$37,953.00

- B. The Township Committee acknowledges the terms and conditions for administering the Municipal Alliance grant, including the administrative compliance and audit requirements.
- C. The Mayor or his designee is authorized to sign the application
