

**RESOLUTION NO. 083-2014**

**RESOLUTION OF THE MAYOR AND COMMITTEE OF THE TOWNSHIP OF HARRISON  
AUTHORIZING EXECUTION OF AN AGREEMENT WITH NEW JERSEY DEPARTMENT  
OF TRANSPORTATION (“NJDOT”) FOR INSTALLATION OF TRAFFIC LIGHT AT  
INTERSECTION OF S.H. ROUTE 77 AND S.H. ROUTE 45**

**WHEREAS**, a need exists for a traffic signal at the intersection of S.H. Route 77 and S.H. Route 45; and

**WHEREAS**, NJDOT has agreed to conduct a study and cost analysis to determine the necessity of the traffic signal, as well the associated costs; and

**WHEREAS**, if the traffic signal is installed, Harrison Township is obligated to pay twenty-five percent (25%) of the utility costs relating to the operation of said traffic signal; and

**WHEREAS**, it is in the best interests of the residents of the Township of Harrison to authorize the NJDOT to install a traffic light at the intersection at the intersection of S.H. Route 77 and S.H. Route 45.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Committee of the Township of Harrison, County of Gloucester and State of New Jersey that the Mayor and Clerk are hereby authorized to execute an agreement with New Jersey Department of Transportation which obligates Harrison Township to pay twenty-five percent (25%) of the utility cost relating to the operation of said traffic signal.

**ADOPTED** at a regular meeting of the Mayor and Township Committee of the Township of Harrison, County of Gloucester, State of New Jersey held on March 5, 2014.
