**RESOLUTION OF THE MAYOR AND COMMITTEE OF THE TOWNSHIP  
OF HARRISON AUTHORIZING THE APPOINTMENT OF MARIA BERKETT  
TO THE POSITION OF DEPUTY TAX COLLECTOR**

**WHEREAS**, the Township of Harrison has established the position of Deputy Tax Collector identified within §43-36 of the Code of the Township of Harrison; and

**WHEREAS**, §43-37 of the Code of the Township of Harrison sets forth the duties and responsibilities of the Deputy Tax Collector; and

**WHEREAS**, Maria Berkett has agreed to accept the position of Deputy Tax Collector for the compensation and hours prescribed by the Township Committee.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Committee of the Township of Harrison, County of Gloucester, and State of New Jersey that the Mayor and Committee that Maria Berkett is hereby appointed as the Deputy Tax Collector for a term of one year expiring December 31, 2015.

**BE IT FURTHER RESOLVED** that the compensation and maximum work hours of the Deputy Tax Collector is as follows:

- 1) Compensation - \$16.58 per hour;
- 2) The Deputy Tax Collector shall not work in excess of twenty (20) hours per week unless authorized by the Township Administrator or Township Clerk.
