

**RESOLUTION NO. 046-2015**

**RESOLUTION OF THE MAYOR AND COMMITTEE OF THE TOWNSHIP OF HARRISON, IN THE COUNTY OF GLOUCESTER, STATE OF NEW JERSEY AUTHORIZING A CONTRACT BY AND BETWEEN THE TOWNSHIP OF HARRISON AND THE SOCIETY TO PROTECT ANIMALS FOR CONDUCTING DOG AND CAT CENSUS FOR 2015**

**WHEREAS**, pursuant to *N.J.S.A. 4:19 et. seq.*, municipalities are required to conduct a dog and cat census every two (2) years; and

**WHEREAS**, the Township of Harrison desire to enter into a contract with The Society to Protect Animals for conducting said census;

**NOW, THEREFORE BE IT RESOLVED** by the Township Committee of the Township of Harrison as follows:

1. That the Township Committee of the Township of Harrison hereby authorizes a Contract between the Township of Harrison and The Society to Protect Animals for conducting a dog and cat census within the Township of Harrison according to the terms of the Contract attached hereto.
2. That the Contract shall commence after April 1, 2015 and will be completed on or before September 1, 2015. A copy of the completed census will be sent to the New Jersey Department of Health for their records.
3. The Society will be paid \$10,000 for these services in 4 payments of \$2,500 starting at the time that the door-to-door canvassing begins.
4. That the Mayor and Clerk are authorized and directed to execute the attached Agreement.
