**RESOLUTION OF THE MAYOR AND COMMITTEE OF THE TOWNSHIP
OF HARRISON AUTHORIZING THE DISPOSAL OF SURPLUS PROPERTY THROUGH
GOVDEALS.COM ONLINE AUCTION SERVICE**

WHEREAS, the Township of Harrison is the owner of certain surplus property which is no longer needed for public use; and

WHEREAS, the Township of Harrison is desirous of selling said surplus property in an "as is" condition without express or implied warranties.

NOW THEREFORE, be it RESOLVED by the Township of Harrison in the County of Gloucester;

(1) The sale of the surplus property shall be conducted through GovDeals pursuant to State Contract A-83453/T2581 in accordance with the terms and conditions of the State Contract. The terms and conditions of the agreement entered into with GovDeals is available online at govdeals.com and also available from the Municipal Clerk.

(2) The sale will be conducted online and the address of the auction site is govdeals.com.

(3) The sale is being conducted pursuant to Local Finance Notice 2008-9.

(4) A list of the surplus property to be sold is as follows: 1990 Ford 1920 Compact tractor Serial No. UP26454, 1999 Case C70 tractor Serial No. JJE1007549, 1991 Toro Groundsmaster 345 Mower Serial No. 00554, Alamo SHD88 Flail Mower Serial No. 20574 and Bush hog five-foot rotary mower;

(5) The surplus property as identified shall be sold in an "as-is" condition without express or implied warranties with the successful bidder required to execute a Hold Harmless and Indemnification Agreement concerning use of said surplus property.

(6) The Township of Harrison reserves the right to accept or reject any bid submitted.
