**RESOLUTION OF THE MAYOR AND COMMITTEE OF THE TOWNSHIP OF HARRISON  
AUTHORIZING RELEASE OF THE MAINTENANCE GUARANTEE PROVIDED BY B&H  
CONTRACTING, INC. AFFECTING THE CONSTRUCTION OF A SLUDGE PRESS AT THE  
WWTF IN THE TOWNSHIP OF HARRISON, COUNTY OF GLOUCESTER, STATE OF NEW

**WHEREAS**, the Applicant, B&H Contracting, Inc., has caused certain work to be performed relating to the construction of a sludge press at the WWTF; and

**WHEREAS**, previously, the Applicant posted a Maintenance Surety Bond dated February 25, 2013 in the sum of \$63,954.20; and

**WHEREAS**, the aforementioned Guarantee expires on February 25, 2015; and

**WHEREAS**, the Guarantee presently held by the Township Clerk in the following sum shall be returned to the Applicant along with any remaining escrow:

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Harrison, County of Gloucester and State of New Jersey as follows:

1. The original Maintenance Bond dated February 25, 2013 in the sum of \$63,954.20 shall be released and returned to the Applicant.
2. That no above-mentioned Maintenance Guarantee shall be released until payment by the Applicant of any outstanding fees or costs from inspections or escrows.
3. The Township Clerk is hereby directed to forward certified copies of this Resolution to the Applicant and the Harrison Township WWTF Engineer.
