**RESOLUTION BY THE MAYOR AND COMMITTEE OF THE TOWNSHIP OF

**WHEREAS**, the Township of Harrison will provide medical and prescription coverage to its' employees through United Healthcare/Oxford, and dental and vision coverage through MetLife Insurance Companies effective April 1, 2015 and

**WHEREAS**, Broker Joseph C. Ablahani of Capital Benefits LLC, has received a quote for medical and prescription coverage on behalf of the Township of Harrison and;

**WHEREAS**, Broker Mike Previti of MetLife Insurance has received a quote for dental and vision coverage on behalf of the Township of Harrison and;

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Township Committee of the Township of Harrison, in the County of Gloucester, State of New Jersey, that the Township provide medical coverage for all of its active and retired employees through United Healthcare/Oxford and MetLife Insurance Companies.
