

**RESOLUTION NO. 130-2015**

**RESOLUTION OF THE MAYOR AND COMMITTEE OF THE TOWNSHIP  
OF HARRISON AUTHORIZING THE HIRING OF A PART-TIME PATROLMAN**

**WHEREAS**, the Chief of Police, Thomas F. Mills, has recommended the hiring of an additional part-time police officer for the Township of Harrison Police Department; and

**WHEREAS**, Kevin P. McGowan has served as a SLEO II for the Harrison Township Police Department commencing on October 6, 2014 and has since served successfully in that position; and

**WHEREAS**, the Mayor and Committee of the Township of Harrison have concurred with the Chief of Police's recommendation; and

**WHEREAS**, Chief Thomas F. Mills has recommended the hiring of Kevin P. McGowan as a part-time patrolman.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Committee of the Township of Harrison that:

1. The Chief of Police and Township Clerk are hereby authorized to take any and all steps necessary to hire Kevin P. McGowan as a Patrolman, part-time, for the Township of Harrison; and
2. Officer McGowan shall be hired effective immediately or after the Officer has successfully passed a psychological examination; physical examination and State-mandated drug screening test, whichever date occurs last.
