

RESOLUTION NO. 83-2015

**RESOLUTION BY THE TOWNSHIP COMMITTEE, IN THE TOWNSHIP OF
HARRISON, COUNTY OF GLOUCESTER AND STATE OF NEW JERSEY AUTHORIZING
STATE CONTRACT PURCHASE OF ONE (1) 2015, OR NEWER, FORD F-350**

WHEREAS, the Township of Harrison wishes to purchase one (1) 2015, or newer, Ford F-350 reg cab four-wheel drive pickup truck with published options from an authorized vendor under the State of New Jersey Cooperative Purchasing; and

WHEREAS, the purchase of goods and services by local contracting units is authorized by the Local Public Contracts Law, N.J. S.A. 40A:11-12; and

WHEREAS, Winner Ford has been awarded New Jersey Contract No. A83558 for 2015 Ford F-350 reg cab four-wheel drive pickup truck with published options; and

WHEREAS, the Deputy Township Administrator recommends the utilization of this contract on the grounds that it represents the best price available; and

WHEREAS, the actual cost for the purchase of one (1) 2015, or newer, Ford F-350 reg cab four-wheel drive pickup truck with published options is expected not to exceed \$28,000.00; and

NOW, THEREFORE, BE IT RESOLVED By the Township Committee of the Township of Harrison, County of Gloucester and State of New Jersey, as follows:

1. Chas S Winner, DBA Winner Ford, 250 Berlin Road, Cherry Hill, NJ 08034 is hereby awarded a contract in an amount not to exceed \$28,000.00 to supply one (1) 2015, or newer, Ford F-350 reg cab four-wheel drive pickup truck with published options for the Township.
2. A Certification of Funds has been received for the said contract assuring that there is a sufficient appropriation to award this contract and the availability of a sufficient appropriation to fund the purchase authorized in this resolution is an express and mandatory condition of the award of this contract.
3. The Deputy Township Administrator hereby is authorized to sign the contract documents necessary to effectuate the award of this contract.
