

RESOLUTION NO. 100-2016

**RESOLUTION BY THE TOWNSHIP COMMITTEE, IN THE TOWNSHIP OF
HARRISON, COUNTY OF GLOUCESTER AND STATE OF NEW JERSEY AUTHORIZING
STATE CONTRACT FOR UPGRADES OF PUMP STATION FLOW METERS**

WHEREAS, the Township of Harrison wishes to receive upgrades to pump station flow meter from an authorized vendor under the State of New Jersey Cooperative Purchasing; and

WHEREAS, the purchase of goods and services by local contracting units is authorized by the Local Public Contracts Law, N.J. S.A. 40A:11-12; and

WHEREAS, Applied Analytics Ltd. has been awarded New Jersey Contract No. A85089-T0983 for the upgrading of pump station flow meters; and

WHEREAS, the Superintendent of Wastewater Treatment Facility recommends the utilization of this contract on the grounds that it represents the best price available; and

WHEREAS, the actual cost for the upgrades of pump station flow meters is expected not to exceed \$4,815.94; and

NOW, THEREFORE, BE IT RESOLVED By the Township Committee of the Township of Harrison, County of Gloucester and State of New Jersey, as follows:

1. Applied Analytics Ltd., One Highway 12, Plaza One, Flemington, NJ 08822 is hereby awarded a contract in an amount not to exceed \$4,815.94 to supply repair (6) pump station flow meters for the Township.
2. A Certification of Funds has been received for the said contract assuring that there is a sufficient appropriation to award this contract and the availability of a sufficient appropriation to fund the purchase authorized in this resolution is an express and mandatory condition of the award of this contract.
3. The Superintendent of Wastewater Treatment Facility hereby is authorized to sign the contract documents necessary to effectuate the award of this contract.
