**RESOLUTION OF THE MAYOR AND COMMITTEE OF THE TOWNSHIP OF
HARRISON AUTHORIZING THE EXECUTION OF A SHARED SERVICES
AGREEMENT WITH CLEARVIEW REGIONAL HIGH SCHOOL RELATING TO AN
INVESTIGATION OF RENEWABLE ENERGY OPTIONS**

WHEREAS, Harrison Township owns and maintains large parcels of unimproved property;
and

WHEREAS, the unimproved tracts of property can be utilized to support renewable energy projects that would benefit the Township and other institutional users of energy, such as our schools; and

WHEREAS, Harrison Township and Clearview Regional High School seeks to investigate and develop a model to properly plan for and implement effective cost-saving energy projects; and

WHEREAS, Harrison Township seeks to conduct an investigation to determine the feasibility and potential cost-savings of constructing a photovoltaic system, as well as other energy efficient projects, on the Township's unimproved properties; and

WHEREAS, the objective of the investigation is to determine whether a proposed renewable energy project could result in substantial energy cost-savings to the Township and the school, as well as a reduction in their carbon footprint; and

WHEREAS, the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1, et seq., permits local units of this State to enter into a contract with any other governmental unit for shared services; and

WHEREAS, Clearview Regional High School has agreed to provide authorization of an investigation to determine the feasibility of constructing a renewable energy project which would benefit the Township and the school; and

WHEREAS, such Agreements are encouraged by the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1, et seq.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Committee of the Township of Harrison, County of Gloucester, State of New Jersey, as follows:

1. The Mayor and Committee of the Township of Harrison authorize the Mayor and Clerk to execute a Shared Services Agreement with Clearview Regional High School in the form and manner attached hereto.
