

**RESOLUTION NO. 129-2016**

**RESOLUTION BY THE TOWNSHIP COMMITTEE, OF THE TOWNSHIP OF  
HARRISON, IN THE COUNTY OF GLOUCESTER, STATE OF NEW JERSEY  
AUTHORIZING THE REFUND OF REAL ESTATE TAXES PAID IN THE YEAR 2016,  
IN THE AMOUNT OF \$ 279.12**

**WHEREAS**, the Tax Collector of Harrison Township advised that Walter McGuire was determined to be classified as a “Total Disabled Veteran” by the County Tax Assessor as of March 18, 2014; and

**WHEREAS**, the Tax Collector of Harrison Township advised that Resolution 105-2014 was adopted April 21, 2014, canceling the real estate taxes for Block 43, Lot 7.01 pursuant to Walter J. McGuire’s “Total Disabled Veteran” exemption status; and

**WHEREAS**, the Tax Collector of Harrison Township has determined that Walter J. McGuire overpaid real estate taxes due to a Homestead Rebate being applied to the referenced block and lot in 2016, and is entitled to have such overpayment refunded; and
