**RESOLUTION OF THE MAYOR AND COMMITTEE OF THE TOWNSHIP OF HARRISON
AUTHORIZING EXECUTION OF A UTILITY ENGINEERING AND CONSTRUCTION
AGREEMENT UECA-5-45-RACCOON CREEK BRIDGE143280
BETWEEN THE STATE OF NEW JERSEY, DEPARTMENT OF TRANSPORTATION
AND THE TOWNSHIP OF HARRISON**

WHEREAS, the New Jersey Department of Transportation ("NJDOT") has agreed to undertake the design and construction of the S.H. Route 45 bridge over Raccoon Creek; designated as NJDOT UECA-5-45-Raccoon Creek Bridge-143280, UPC Code: 143280, Contract ID No.: 16 14060; and

WHEREAS, the project requires the construction of new, and/or the protection, relocation and/or adjustment of the Township's existing wastewater infrastructure; and

WHEREAS, the Agreement provides for mutual cooperation in Plans and cost estimates for the work necessitated by the project; and

WHEREAS, it is in the best interest of the residents of the Township of Harrison to authorize the execution of the Utility Engineering and Construction Agreement for the aforementioned project.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Committee of the Township of Harrison, County of Gloucester, State of New Jersey, as follows:

1) The execution of the Utility Engineering and Construction Agreement relating to the project identified as NJDOT UECA-5-45-Raccoon Creek Bridge-143280, UPC Code: 143280, Contract ID No.: 16 14060 is hereby authorized and approved.

2) The Mayor, Louis F. Manzo, and/or the Township Administrator, Mark Gravinese, and/or Wastewater Superintendent, Mike Gonserkevis, be and is hereby authorized to execute said Agreement on behalf of the Township of Harrison.
