

RESOLUTION NO. 136- 2016

RESOLUTION OF THE MAYOR AND COMMITTEE OF THE TOWNSHIP OF HARRISON AUTHORIZING RELEASE OF THE EXPIRED MAINTENANCE GUARANTEE PROVIDED BY LUCREZIA D. SCORDO AFFECTING THE PARCEL KNOWN AS BLOCK 31, LOT 11.06 ON THE OFFICIAL TAX MAP OF THE TOWNSHIP OF HARRISON, COUNTY OF GLOUCESTER, STATE OF NEW JERSEY

WHEREAS, the Applicant, Lucrezia Scordo, obtained Preliminary and Final Site Plan approval relating to Block 31, Lot 11.06 via Harrison Township Planning Board Resolution 33-2013 adopted on July 18, 2013;

WHEREAS, previously, the Applicant posted a cash Maintenance Guarantee dated October 15, 2013 in the sum of \$1,020.00; and

WHEREAS, the aforementioned Maintenance Guarantee expired on May 19, 2016; and

WHEREAS, the Maintenance Guarantee presently held by the Township Clerk in the following sum shall be returned to the applicant:
