

RESOLUTION NO. 173-2016

**RESOLUTION BY THE TOWNSHIP COMMITTEE, IN THE TOWNSHIP OF HARRISON,
COUNTY OF GLOUCESTER AND STATE OF NEW JERSEY AUTHORIZING THE
PURCHASE OF ONE BANDIT BEAST 2680XP HORIZONTAL GRINDER THROUGH THE
NATIONAL JOINT POWERS ALLIANCE CO-OP**

WHEREAS, the Township of Harrison wishes to purchase one (1) **BANDIT BEAST 2680XP HORIZONTAL GRINDER** from an authorized vendor under the **NATIONAL JOINT POWERS ALLIANCE CO-OP**; and

WHEREAS, the Township of Harrison is permitted to join national cooperative purchasing agreements under the authority of N.J.S.A. 52:34-6.2(b)(3); and

WHEREAS, the **NATIONAL JOINT POWERS ALLIANCE CO-OP** has been awarded Contract No. 031014-BAN for ONE (1) **BANDIT BEAST 2680XP HORIZONTAL GRINDER**; and

WHEREAS, award of this contract is contingent upon completion of the mandatory ten (10) day comment period which expires July 29, 2016 at 4:00 p.m.; and

WHEREAS, the Deputy Township Administrator recommends the utilization of this contract on the grounds that it represents the best price available; and

WHEREAS, the cost for the purchase of ONE (1) **BANDIT BEAST 2680XP HORIZONTAL GRINDER** is **\$440,099.97**; and

WHEREAS, the contract award will be withdrawn if any objections or competitive quotes are delivered to you on or before the expiration of the ten day comment period.

NOW, THEREFORE, BE IT RESOLVED By the Township Committee of the Township of Harrison, County of Gloucester and State of New Jersey, as follows:

1. **BANDIT INDUSTRIES, 6750 MILLBROOK RD., REMUS, MI 49340** shall be awarded a contract pending the completion of the legal advertising requirements. Said contract shall be in an amount not to exceed **\$440,099.97** to supply ONE (1) **BANDIT BEAST 2680XP HORIZONTAL GRINDER** for the Township.

2. A Certification of Funds has been received for the said contract assuring that there is a sufficient appropriation to award this contract and the availability of a sufficient appropriation to fund the purchase authorized in this resolution is an express and mandatory condition of the award of this contract.

3. The Deputy Township Administrator hereby is authorized to sign the contract documents necessary to effectuate the award of this contract as detailed herein.
