

**RESOLUTION NO. 211-2016**

**RESOLUTION BY THE TOWNSHIP COMMITTEE, IN THE TOWNSHIP OF  
HARRISON, COUNTY OF GLOUCESTER AND STATE OF NEW JERSEY AUTHORIZING  
STATE CONTRACT PURCHASE OF ONE (1) 2016, OR NEWER, CHEVROLET TAHOE PPV  
4X4**

**WHEREAS**, the Township of Harrison wishes to purchase one (1) 2016, or newer, Chevrolet Tahoe PPV 4X4 from an authorized vendor under the State of New Jersey Cooperative Purchasing; and

**WHEREAS**, the purchase of goods and services by local contracting units is authorized by the Local Public Contracts Law, N.J. S.A. 40A:11-12; and

**WHEREAS**, Day Fleet Sales has been awarded New Jersey Contract No. 89938 for 2016 Chevrolet Tahoes; and

**WHEREAS**, the Deputy Township Administrator recommends the utilization of this contract on the grounds that it represents the best price available; and

**WHEREAS**, the actual cost for the purchase of one (1) 2016, or newer, Chevrolet Tahoe PPV 4X4 is expected not to exceed \$37,035.44; and

**NOW, THEREFORE, BE IT RESOLVED** By the Township Committee of the Township of Harrison, County of Gloucester and State of New Jersey, as follows:

1. Day Fleet Sales, 1600 Golden Mile Hwy., Monroeville, Pennsylvania 15146 is hereby awarded a contract in an amount not to exceed \$37,035.44 to supply one (1) 2016, or newer, Chevrolet Tahoe PPV 4X4 for the Township.
2. A Certification of Funds has been received for the said contract assuring that there is a sufficient appropriation to award this contract and the availability of a sufficient appropriation to fund the purchase authorized in this resolution is an express and mandatory condition of the award of this contract.
3. The Deputy Township Administrator hereby is authorized to sign the contract documents necessary to effectuate the award of this contract.
