

**RESOLUTION NO. 214 -2016**

**RESOLUTION OF THE MAYOR AND COMMITTEE OF THE TOWNSHIP OF HARRISON  
AUTHORIZING ISSUANCE OF ONE (1) PLENARY RETAIL  
CONSUMPTION LIQUOR LICENSE TO ROMEO, LLC**

**WHEREAS**, on September 20, 2016, the Harrison Township Committee, via Resolution No. 194-2016 and Resolution No. 201-2016 amending Resolution No. 194-2016 adopted on October 3, 2016, accepted the bid by Romeo, LLC for one (1) new Plenary Retail Consumption Liquor License; and

**WHEREAS**, Romeo, LLC met all prerequisite conditions of license issuance, and is qualified to be licensed according to all standards established by Title 33 of the New Jersey State Statutes and Regulations promulgated thereunder, as well as pertinent local ordinances and conditions consistent with Title 33; and

**WHEREAS**, request for a new license was duly advertised in the *South Jersey Times*, a newspaper circulated in the Township of Harrison and no objections, either verbally or in writing, were filed or made to the Harrison Township Committee or the Municipal Clerk regarding said new license; and

**WHEREAS**, the submitted application form is complete in all respects and the fees have been paid and background checks have been made on the Applicant by the Harrison Township Police Department.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Committee of the Township of Harrison, County of Gloucester and State of New Jersey, that one (1) new Plenary Retail Consumption Liquor License be granted and issued to Romeo, LLC, 1598 Monroeville Road, Monroeville, New Jersey 08043, effective immediately; and

**BE IT FURTHER RESOLVED** that the Municipal Clerk is hereby authorized and directed to execute the endorsement of a new Plenary Retail Consumption Liquor License on behalf of the Mayor and Township Committee of the Township of Harrison; and

**BE IT FURTHER RESOLVED** that two (2) copies of this Resolution be sent to the State of New Jersey, Department of Law and Public Safety, Division of Alcoholic Beverage Control, Licensing Bureau, P.O. Box 087, Trenton, New Jersey.
