

RESOLUTION NO. 217-2016

**RESOLUTION BY THE TOWNSHIP COMMITTEE, IN THE TOWNSHIP OF HARRISON,
COUNTY OF GLOUCESTER AND STATE OF NEW JERSEY AUTHORIZING THE
PURCHASE AND INSTALLATION OF ALCATEL-LUCENT DATA NETWORK AND
WIRELESS NETWORK IN THE NEW POLICE STATION THROUGH THE
EDUCATIONALSERVICES COMMISSION OF NEW JERSEY CO-OP**

WHEREAS, the Township of Harrison wishes to **PURCHASE AND INSTALL ALCATEL-LUCENT DATA NETWORK AND WIRELESS NETWORK IN THE NEW POLICE STATION** from an authorized vendor under the **EDUCATIONALSERVICES COMMISSION OF NEW JERSEY CO-OP** ; and

WHEREAS, the Township of Harrison is permitted to join national cooperative purchasing agreements under the authority of N.J.S.A. 52:34-6.2(b)(3); and

WHEREAS, the **EDUCATIONALSERVICES COMMISSION OF NEW JERSEY CO-OP** has been awarded Contract No. MRESC 14/15-76 for the **PURCHASE AND INSTALLING OF ALCATEL-LUCENT DATA NETWORK AND WIRELESS NETWORK IN THE NEW POLICE STATION**; and

WHEREAS, award of this contract is contingent upon completion of the mandatory ten (10) day comment period which expires November 18, 2016 at 4:00 p.m.; and

WHEREAS, the Deputy Township Administrator recommends the utilization of this contract on the grounds that it represents the best price available; and

WHEREAS, the cost for the **PURCHASE AND INSTALLING OF ALCATEL-LUCENT DATA NETWORK AND WIRELESS NETWORK IN THE NEW POLICE STATION** is **\$14,051.00**; and

WHEREAS, the contract award will be withdrawn if any objections or competitive quotes are delivered to you on or before the expiration of the ten day comment period.

NOW, THEREFORE, BE IT RESOLVED By the Township Committee of the Township of Harrison, County of Gloucester and State of New Jersey, as follows:

1. **RFP Solutions, 10F Greenwood Ave, Woodbury, NJ 08096** shall be awarded a contract pending the completion of the legal advertising requirements. Said contract shall be in an amount not to exceed **\$14,051.00** for **PURCHASE AND INSTALLING OF ALCATEL-LUCENT DATA NETWORK AND WIRELESS NETWORK IN THE NEW POLICE STATION** for the Township.
2. A Certification of Funds has been received for the said contract assuring that there is a sufficient appropriation to award this contract and the availability of a sufficient appropriation to fund the purchase authorized in this resolution is an express and mandatory condition of the award of this contract.
3. The Deputy Township Administrator hereby is authorized to sign the contract documents necessary to effectuate the award of this contract as detailed herein.
