

**RESOLUTION NO. 222-2016**

**RESOLUTION BY THE TOWNSHIP COMMITTEE, IN THE TOWNSHIP OF HARRISON, COUNTY OF GLOUCESTER AND STATE OF NEW JERSEY AUTHORIZING STATE CONTRACT PURCHASE TO SUPPLY AND INSTALL HIGH DENSITY FILE SYSTEMS, LOCKERS AND EVIDENCE AND ARMORY STORAGE EQUIPMENT IN NEW POLICE FACILITY**

**WHEREAS**, the Township of Harrison wishes to purchase and install **HIGH DENSITY FILE SYSTEMS, LOCKERS AND EVIDENCE AND ARMORY STORAGE EQUIPMENT IN NEW POLICE FACILITY** from an authorized vendor under the State of New Jersey Cooperative Purchasing; and

**WHEREAS**, the purchase of goods and services by local contracting units is authorized by the Local Public Contracts Law, N.J. S.A. 40A:11-12; and

**WHEREAS**, Diversified Storage Solutions Inc., 56 Buttonwood Street, Norristown, Pa 19401 has been awarded New Jersey Contract No. A79829 for purchase and install **HIGH DENSITY FILE SYSTEMS, LOCKERS AND EVIDENCE AND ARMORY STORAGE EQUIPMENT IN NEW POLICE FACILITY**; and

**WHEREAS**, the Deputy Township Administrator recommends the utilization of this contract on the grounds that it represents the best price available; and

**WHEREAS**, the actual cost for the purchase and installation of **HIGH DENSITY FILE SYSTEMS, LOCKERS AND EVIDENCE AND ARMORY STORAGE EQUIPMENT IN NEW POLICE FACILITY** is expected not to exceed \$170,614.67; and

**NOW, THEREFORE, BE IT RESOLVED** By the Township Committee of the Township of Harrison, County of Gloucester and State of New Jersey, as follows:

1. Diversified Storage Solutions Inc., 56 Buttonwood Street, Norristown, Pa 19401 is hereby awarded a contract in an amount not to exceed \$170,614.67 for the purchase and installation of a **HIGH DENSITY FILE SYSTEMS, LOCKERS AND EVIDENCE AND ARMORY STORAGE EQUIPMENT IN NEW POLICE FACILITY** for the Township.

2. A Certification of Funds has been received for the said contract assuring that there is a sufficient appropriation to award this contract and the availability of a sufficient appropriation to fund the purchase authorized in this resolution is an express and mandatory condition of the award of this contract.

3. The Deputy Township Administrator hereby is authorized to sign the contract documents necessary to effectuate the award of this contract.
