**RESOLUTION BY THE TOWNSHIP COMMITTEE, IN THE TOWNSHIP OF HARRISON,  
COUNTY OF GLOUCESTER AND STATE OF NEW JERSEY AUTHORIZING THE  
PURCHASE OF ONE (1) ONE (1) BOBCAT 5600 TOOLCAT UTILITY WORK MACHINE  
THROUGH A COOPERATIVE PURCHASING AGREEMENT**

**WHEREAS**, the Township of Harrison wishes to **PURCHASE ONE (1) BOBCAT 5600 TOOLCAT UTILITY WORK MACHINE** from an authorized vendor under the **EDUCATIONAL SERVICES COMMISSIONS OF NEW JERSEY CO-OP**; and

**WHEREAS**, the **EDUCATIONAL SERVICES COMMISSIONS OF NEW JERSEY CO-OP** has been awarded Contract No. 15/16-08 for the **PURCHASE OF ONE (1) BOBCAT 5600 TOOLCAT UTILITY WORK MACHINE**; and

**WHEREAS**, award of this contract is contingent upon completion of the mandatory ten (10) day comment period which expires November 18, 2016 at 4:00 p.m.; and

**WHEREAS**, the Deputy Township Administrator recommends the utilization of this contract on the grounds that it represents the best price available; and

**WHEREAS**, the cost for the purchase of **ONE (1) BOBCAT 5600 TOOLCAT UTILITY WORK MACHINE** is **\$58,061.47**; and

**WHEREAS**, the contract award will be withdrawn if any objections or competitive quotes are delivered to you on or before the expiration of the ten day comment period.

**NOW, THEREFORE, BE IT RESOLVED** By the Township Committee of the Township of Harrison, County of Gloucester and State of New Jersey, as follows:

1. **Garden State Bobcat Inc., 999 Route 33, Freehold, NJ 07728** shall be awarded a contract pending the completion of the legal advertising requirements. Said contract shall be in an amount not to exceed **\$58,061.47** for the purchase of **ONE (1) BOBCAT 5600 TOOLCAT UTILITY WORK MACHINE** for the Township.

2. A Certification of Funds has been received for the said contract assuring that there is a sufficient appropriation to award this contract and the availability of a sufficient appropriation to fund the purchase authorized in this resolution is an express and mandatory condition of the award of this contract.

3. The Deputy Township Administrator hereby is authorized to sign the contract documents necessary to effectuate the award of this contract as detailed herein.
