

**RESOLUTION NO. 60-2016**

**RESOLUTION OF THE MAYOR AND COMMITTEE OF THE TOWNSHIP OF HARRISON  
DESIGNATING REGULAR AND WORK SESSION MEETINGS AND OFFICIAL  
NEWSPAPERS FOR THE TOWNSHIP OF HARRISON, IN THE COUNTY OF GLOUCESTER,  
AND STATE OF NEW JERSEY**

**WHEREAS**, the Township Committee of the Township of Harrison, in the County of Gloucester is required pursuant to the provisions of the Open Public Meetings Act Chapter 231, P.L. 1975 of the laws of the State of New Jersey to provide notice of all meetings as specified in said Act.

**NOW, THEREFORE BE IT RESOLVED** by the Township Committee of the Township of Harrison as follows:

1. The Municipal Clerk shall post a copy of this Resolution on the bulletin board in the Municipal Building, located at 114 Bridgeton Pike, Mullica Hill, New Jersey, 08062;

2. A copy of this Resolution together with all required advance written notice shall be given by the Municipal Clerk to the following two (2) newspapers:

3. Work Session Meetings shall be held the first Monday of each month and Regular Business Meetings shall be the third Monday of each month with exceptions holidays or the exceptions noted within the attached schedule. Said meetings shall begin at 7:30 p.m. unless otherwise noted. Formal action will be taken at said meetings. Meeting schedule for the year 2014 is as follows:

4. The Township Committee may conduct Executive Sessions at any of the scheduled meetings without having to provide advance notice of intent to conduct a Closed Executive Session.

5. The schedule of Township Committee Work Session Meetings and Regular Business Meetings for the year 2016 shall be in accordance with the notice annexed hereto.

6. The Municipal Clerk is directed to mail all advance written notices of meetings, as defined by the Open Public Meetings Act, to all persons requesting a copy upon payment of a fee to cover costs of reproduction, handling and mailing. However, newspapers shall be exempt from such fees.

7. The Municipal Clerk shall be required to maintain a list of all duly scheduled meetings of all boards, commissions, and such other agencies within the Township as required to comply with the provisions of the Open Public Meetings Act.

**BE IT FURTHER RESOLVED** by the Township Committee of the Township of Harrison that this Resolution shall take effect immediately upon adoption.
