**RESOLUTION OF THE MAYOR AND COMMITTEE OF THE TOWNSHIP OF  
HARRISON AUTHORIZING THE EXECUTION OF A SHARED SERVICES  
AGREEMENT WITH THE KINGSWAY REGIONAL SCHOOL DISTRICT FOR THE  
PROVISION OF INFORMATION TECHNOLOGY MANAGEMENT SERVICES AND  
RELATED EQUIPMENT**

**WHEREAS**, the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1, et seq., permits local units of this state to enter into a contract with any other governmental unit for shared services; and

**WHEREAS**, the Township of Harrison is in need of a vendor to provide information technology management services and related equipment to the Township; and

**WHEREAS**, the Kingsway Regional School District has agreed to provide information technology management services to the Township of Harrison pursuant to the terms and conditions set forth in the Proposal, attached hereto as Exhibit "A", for a one-year term commencing January 1, 2016 and ending December 31, 2016; and

**WHEREAS**, such Agreements are encouraged by the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1, et seq.

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Committee of the Township of Harrison, County of Gloucester, State of New Jersey, as follows:

1. The Mayor and Clerk of the Township of Harrison are hereby authorized to execute a Shared Services Agreement with the Kingsway Regional School District.
2. A copy of this Resolution and the Agreement shall be filed with the Commissioner of the Department of Community Affairs.
