

**RESOLUTION NO. 91-2016**

**RESOLUTION AUTHORIZING THE RELEASE OF MAINTENANCE SURETY BOND NO. 08845176 FOR ADDITIONAL STORMWATER IMPROVEMENTS FOR THE WHEATLEY MEADOWS SUBDIVISION AFFECTING A PARCEL KNOWN AS BLOCK 57, LOT 19 ON THE OFFICIAL TAX MAP OF THE TOWNSHIP OF HARRISON, COUNTY OF GLOUCESTER, STATE OF NEW JERSEY**

**WHEREAS**, the Applicant has requested that the aforementioned Maintenance Surety Bond dated June 7, 2006 be released and replaced with the aforesaid Maintenance Surety Bond dated December 4 2015; and

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Committee of the Township of Harrison, Gloucester County, New Jersey, as follows:

1. Maintenance Surety Bond No. 08845176 dated June 7, 2006 in the sum of \$13,870.50 issued by Lexon Insurance Company is hereby released and may be returned to the Applicant.
2. Maintenance Surety Bond No. 1113283 dated December 4, 2015 in the sum of \$13,870.50 issued by Lexon Insurance Company was previously accepted as replacement surety to the above-mentioned Maintenance Surety Bond dated June 7, 2006.
3. The Township Clerk is hereby directed to forward a certified copy of this Resolution to the Applicant, and return the June 7, 2006 Maintenance Surety Bond (No. 08845176).
