**RESOLUTION OF THE MAYOR AND COMMITTEE OF THE TOWNSHIP OF HARRISON
AUTHORIZING THE PROMOTION OF PATROLMAN ADAM McEVROY TO THE RANK OF
DETECTIVE WITHIN THE HARRISON TOWNSHIP POLICE DEPARTMENT**

WHEREAS, the governing body of the Township of Harrison operates a police department pursuant to N.J.S.A. 40A:14-118 and 40A:152, and the Code of the Township of Harrison Chapter 53, in order to preserve the public peace, protect life and property, and enforce the laws of the State of New Jersey, and ordinances of the Township of Harrison, among other responsibilities; and

WHEREAS, from time to time it becomes necessary to engage or promote uniformed personnel to efficiently and effectively perform the several duties and obligations of the police department; and

WHEREAS, Patrolman Adam McEvoy has demonstrated his expertise relating to the performance of his duties and obligations within the police department; and

WHEREAS, the Chief of Police of the Township of Harrison has reviewed the qualifications and performance of Patrolman Adam McEvoy, and is recommending to the Township Committee that he be promoted to the rank of Detective within the Harrison Township Police Department.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Committee of the Township of Harrison that the promotion of Patrolman Adam McEvoy to the rank of Detective in the Harrison Township Police Department is hereby authorized and confirmed effective immediately

BE IT FURTHER RESOLVED, that the Chief of Police be and hereby is authorized to take such action as required to effectuate the intent and purpose hereof, with a conformed copy of this Resolution to be placed in the personnel file of Patrolman Adam McEvoy and to be maintained in the official records of the Township of Harrison by the Municipal Clerk; and
