**RESOLUTION OF THE MAYOR AND COMMITTEE OF THE TOWNSHIP OF
HARRISON AUTHORIZING AND APPROVING EXECUTION OF A TREATMENT WORKS
APPROVAL (“TWA”) APPLICATION FOR MULLICA WEST APARTMENTS, LP**

WHEREAS, Mullica West Apartments, LP is the owner of property located at 54 & 58 Woodstown Road, and identified as Block 52, Lots 8 and 9 in the Township of Harrison (commonly known as “Mullica West Apartments”); and

WHEREAS, Mullica West Apartments, LP has submitted for approval and execution a Treatments Work Approval (TWA”) Application seeking authorization for the connection to the Mullica West Apartments; and

WHEREAS, the proposed project relates to the construction of an on-site, privately owned sanitary sewer lateral connection to an existing manhole for service to two new apartment buildings and an office/maintenance building; and

WHEREAS, the Township has reviewed the Application and, specifically, the Engineer’s Report submitted therewith, which is attached hereto and made a part hereof; and

WHEREAS, the Township, in reliance upon said Application and report, has determined the Application to be acceptable subject to the following understandings and conditions.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Committee of the Township of Harrison, County of Gloucester and State of New Jersey that:

1. The governing body does hereby approve and authorize the execution of attached TWA Application by Mullica West Apartments, LP for property located at 54 & 58 Woodstown Road, and identified as Block 52, Lots 8 and 9 in the Township of Harrison (commonly known as “Mullica West Apartments”).

2. The foregoing approval is based on the information submitted by the Applicant in support of the Application and, therefore, is voidable in the sole discretion of the Township in the event that the submitted information is found to be inaccurate or where the project is substantively altered following the adoption of this Resolution.

3. This Resolution shall take immediate effect.
